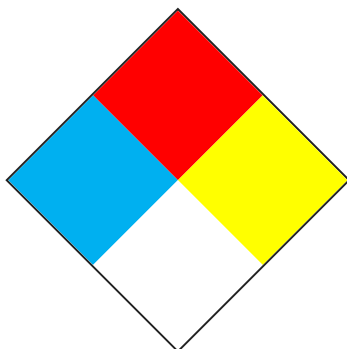

Eye contact:
